1. Roll Call

change it so it racked up bills for WHA. Will try to recoup. May need staff to help tenants who need help. We're down 4 staff people. Hard to find people.

Congressman Larson visited recently and talked with the people for two hours. Mayor and Deputy Mayor as well. Tenants got to know that the community cares about them.

Continue to have an open door policy. Smoking policy is no smoking on the property. People who continue to smoke, they won't get renewed. We work with them to find them another place.

- The town has applied for the CDBG grant to fund Shad Run's exterior (roof, windows, doors).
- Applied for a HTCC grant to redo the roof at Fitch which leaks terribly. Could then add solar at no cost we'd be leasing our roof space. Residents would get 20% rebate and the rest of the stipend would be split between the vendor and WHA.
- One more grant to be applied for NA for \$150,000 tax credits.
